Report of CAB WG 11 - Systems Issues.

TERMS OF REFERENCE (Approved by CAB via correspondence 11 January 2016 (CAB/1477A/RV))

WG 11 has the responsibility to undertake the following activities and make related recommendations for CAB approval on an ongoing basis:

- Develop the modifications to the Harmonized Basic Rules (HBR) necessary to ensure consistency among the Systems and with the IEC Statutes and Rules of Procedure and IEC CAB Policy.
- Review IEC CA Systems Supplements to the HBR.
- Identify opportunities for harmonization of documents and programs at the System level.
- Oversee the development of Harmonized Rules of Procedure and principles for standalone schemes.
- Considers issues associated with System membership of suspended IEC NCs.
- To consider the use by the IEC Systems of non-ISO and non-IEC documents.

BACKGROUND (Brief background and overview of meetings and activities since last reporting)

WG 11 met 6 October 2015 in Frankfurt, Germany, 9-10 December 2016 in Tokyo, Japan and 24-25 February 2016 in Northbrook, IL, USA during the year to consider multiple items as assigned by CAB. The primary focus of the WG since the last report was the completion of the Harmonized Basic Rules (HBR) of the IEC CA Systems. The WG reviewed all comments by the CA Systems, members of CAB and members of the WG and distributed a document that compiled all comments received as well as resolution of those comments.

The result of the meetings was a final version of the HBR for CAB approval by correspondence. The HBR was approved by CAB via correspondence on 12 April 2016. An informational copy of the HBR was distributed to the CA Systems for their use in development of their Supplements.

This report includes an executive summary of activities to date and plans moving forward.

EXECUTIVE SUMMARY (Succinct summary of key items addressed in this report)

WG 11's work was primarily focused on completing the Harmonized Basic Rules for the IEC CA Systems. The HBR were finalized and approved by CAB on 12 April 2016. In addition to the work on the HBR, CAG WG 11 worked on some additional areas including timeline for implementation, other areas for harmonization, prioritization of its activities, development of the concept of Voting and Non-Voting Membership and coordination of the common elements of the CA Systems.

WG 11 has recommendations related to the following:

- Coordination of Subject Matter Experts (SME) from the CAB and CA Systems
- Change to the WG 11 Terms of Reference
- Proposed HBR implementation timeline
- Consistency in the layout and format of the CA Systems Supplements
- Reference to MC subcommittees in CA Systems Supplements with details in 02 level documents
- Solicitation of comments from the CA Systems for the next version of the HBR related to Voting/Non-Voting and Document distribution timelines
- Prioritization of next work areas for WG 11
- Call for Subject Matter Experts from CAB and the Systems for possible work in the area of Personnel Competencies.

The next meeting of CAB WG 11 is scheduled for 14 June 2016 in Geneva.

Part A: Recommendations for approval

(Description of background related to recommendation)

The CAB STF on Governance has proposed the concept of the scheme rules toolbox. The STF indicated that the toolbox concept needs to be further developed, but recognizes that further clarification is needed related to how this will be managed, who will manage it and how divergence issues will be addressed. WG 11 further discussed the issue and felt that expertise from the CA Systems was needed to assist in the alignment and possible harmonization of any new areas for the tool/toolbox approach. As such, WG 11 suggests that it be the coordinating body for these Subject Matter Experts (SME) for the specific areas identified. This is in line with CAB Decision 34/10 and Decision 37/9 (See Part C)

A Recommendation A.1. – WG 11 asks CAB for approval to act as the coordinator of the Subject Matter Experts from the Systems in an effort to harmonize or align aspects. CAB WG 11 recommends that it will act as the reviewing and monitoring body for this tool/toolbox approach.

WG 11 reviewed recommendations from the Council Board, previous CAB decisions and input from WG members regarding the need for review of the CA Systems Rules of Procedure. WG 11 noted the inclusion of the CA System Chairs and Secretaries in its membership and suggests that the expertise for review of CA Systems Rules exists within WG 11. In addition, WG 11 notes the desire expressed in CB/129e for unification of essential rules and processes and suggests that CAB entrust WG 11 with these tasks. WG 11 therefore seeks to modify its Terms of Reference as indicated:

Terms of Reference:

WG 11 has the responsibility to undertake the following activities and make related recommendations for CAB approval on an ongoing basis:

- Develop the modifications to the Harmonized Basic Rules (HBR) necessary to ensure consistency among the CA Systems and with the IEC Statutes and Rules of Procedure and IEC CAB Policy.
- Review IEC CA Systems Supplements to the HBR.
- Act as the reviewing body for the CA System Rules of Procedure to evaluate their compliance with IEC Statutes and Rules of Procedure, CAB Policy and the identification of possible areas for harmonization or alignment.
- Identify opportunities for harmonization of documents and programs at the System level and across the CA Systems.
- Oversee the development of Harmonized Rules of Procedure and principles for standalone schemes.
- Considers issues associated with CA System membership of suspended IEC NCs.
- To consider the use by the IEC Systems of non-ISO and non-IEC documents.

A Recommendation A.2. – Based on approval of Recommendation A.1., WG 11 asks CAB for approval for revised Terms of Reference with changes as indicated in red.

CAB Document CAB/1476/DC describing the proposed timeline for HBR implementation (discussed at the Minsk CAB meeting was circulated to CAB members for review and comment. Positive comments were received by Sweden, Germany, Australia and France. No negative or additional comments were received.

Timeline from CAB/1476/DC

- March 2016 target for a CAB vote by correspondence on the final proposed HBR
- Approved HBR available for CA Systems' management meetings (first IECQ in April 2016)
- CA Systems would work on their respective supplements during 2016
- Implementation of the HBR with supplements would begin 1st January 2017
- 2017 would be a transition year from the current Basic Rules to the HBR with supplements
- Final supplement versions would be approved by CAB at the 2017 General Meeting
- 1st January 2018 the HBR with supplements would be fully implemented.

A Recommendation A.3. – WG 11 notes the positive comments received from CAB members to the timeline proposed in document CAB/1476/DC and recommends formal CAB approval of the proposed implementation timeline.

WG 11 discussed the layout and formatting that would be needed for consistency across the CA Systems for the CA System Supplements and recommends the following:

A Recommendation A.4. – WG 11 recommends that there be a single HBR document (IEC CA 01) and each CA System will have their own document (IECEE 01-S, IECEx 01-S, etc.) which contains ONLY the Supplementary requirements. The formatting of the Clause Number will use numbering convention used by TC61 (e.g. IEC 60335-2-65).

A Recommendation A.5. – WG 11, noting the differences in existence in the management structure of the CA Systems, recommends that references to Committees falling under the MC should be in the Supplement, as to name, function etc,. but Operational issues (Structure, e.g.) for the Committee should be covered in 02 Rules of Procedure documents.

WG 11 noted the comment from Item 10.1 of CAB/1411/RM. The Convener suggested that WG 11 should propose rules for the voting obligations of Member Bodies with some form of down-grading for non-response (along the lines of the Directives clauses 1.7.2 to 1.7.4) and that these should be included in the HBR (see the embedded document just after Recommendation A.7.)

The WG drafted text using the terms "Voting" and "Non-Voting" to distinguish between the two levels of membership of Member Bodies. The only issue addressed is voting rights. There are no differences in the ability to attend meetings, comment on documents, make proposals, WG membership, dues, etc, between the level of Voting Member Body and Non-Voting Member Body.

The intent is that the proposed draft requirements be sent for consideration/comment from the Systems, and that, if/once approved by CAB, the revisions to the HBR be in a 2nd Edition so as to not delay the publication and implementation of the 1st Edition of the HBR.

A Recommendation A.6. – WG 11 requests approval from CAB for WG 11 to directly solicit comments from the Systems related to draft requirements for Voting and Non-Voting Member Body rights and obligations.

WG 11 noted and discussed the differences in document distribution timelines within the current CA Systems and noting the recently approved document distribution timeline for CAB documents, recommends the following:

A Recommendation A.7. – WG 11, recommends that WG 11 to directly solicit comments from the Systems related to a Draft "circulation of documents timeline" table to be included into the HBR.

The document with both Voting/Non-Voting (Recommendation A.6.) and Circulation of Documents Timeline (Recommendation A.7.) were included in a single document with highlights to identify the specific Clauses impacted (blue for Voting/Non-Voting and green for Circulation of Documents Timeline).



WG 11 noted the past CAB decisions (**Decision 34/10** — WG 11, Systems Issues – Harmonization The CAB asks WG 11 to investigate its possibilities to assist the Systems to identify opportunities for harmonization of documents at the scheme level.) proposed changes to the Terms of Reference and discussed possible new areas for harmonization and alignment utilizing Tool/Toolbox approach.

Concepts:

- Identification of opportunities for harmonization of documents and alignment of programs.
- CAB enforcement of IEC Statutes, CAB policy, concepts and rules. Any deviation would require a proposal to change governing documents
- Foster an environment of research and collaboration (prior to embarking on new programs).
 - Collaboration and sharing of new work areas (between existing and new Schemes)
 to allow for identification and use of existing programs/rules
- Raising the knowledge level of participants in CA practices/principles and IEC culture.
 Education of Officers of the Systems on the IEC Statutes and Rules of Procedure and IEC CAB Policy as a requirement
- Create value for those creating new programs/services by sharing and using best practices from the Systems

Deliverables (Possible tools for enhancing alignment):

- High level analysis / document (e.g. blueprint, framework or operating model) that defines top levels priorities and concepts that are required
 - CAB Policy
 - o IEC CA 01 with supplement
 - Develop 02 guide document and template with basic requirements and principles (elements including re-assessment, customer testing facilities).
 - Develop a generic document for rules and procedures for equipment scheme, service scheme and personnel competency scheme. Provides a mandatory baseline
- Need to put in place the structure/mechanism for conducting the analysis and work.
 - o Inclusion of experts from the Systems to do the work.
 - Not repeat past missteps.
- Cross reference list of programs including documents start with the items brainstormed below

- Smart tagging of the documents to facilitate easier searching
- Document storage location where to get the documents

Challenges:

- Compensation for experts working across Systems
- Not invented here mentality
- Perception of a top down mandate and that harmonization leads to a loss of control

Top 3 Prioritized list of brainstormed / identified possible best practice areas:

- 1. Personnel competencies noting IECEx has current program, IECEE is potentially looking to create a Scheme related to Machine Safety and Functional Safety (NECA MOU) and IECRE has expressed a longer term desire
- 2. Peer assessment
- 3. Testing at Customer Facilities IECEE OD-2048 and IECEx OD-024
 - a. Identify common elements and differences

Future potential areas:

- Interpretation of requirements / interaction with standards side (TC/SC)
 - Feedback loop
 - Consistent application of requirements
- Proficiency Testing Program (PTP) principles/operation noting the cooperation between IECEE and IECEx as a success story
- General Non-Conformity Report (GNCR) and Corrective actions
- Mechanisms for issuing and displaying Certificates of Conformity. Online Certificate Database
- Appeals and complaint mechanism/rules
- Documentation Structure and Hierarchy
 - Guidance on document control, naming, implementation (transition period, phase-out, roll-out)
- Harmonized approach to writing 02 level documents best principles/base document or structure
- Propagation of knowledge and past policy decisions
 - Database of decisions available

Based on the brainstorming and analysis, WG 11 suggests that the top three priority areas of work should be Personnel competencies, Peer assessment, and Testing at Customer Facilities. WG 11 therefore recommends the following:

A Recommendation A.8. – WG 11 requests CAB to review the Concepts, Deliverables, Challenges and Possible future areas and approve the following three areas of work as priorities: Personnel Competencies, Peer assessment, and Testing at Customer Facilities.

A Recommendation A.9. – Contingent upon approval of Recommendation 8 and based on the top identified priority (Personnel competencies), WG 11 recommends a call for subject matter experts from the Systems and CAB for work in the area of Certification of Persons to create a standard framework and Scheme document.

3.3. Decision 36/10 — WG 11 Systems Issues – Harmonized Basic Rules

The CAB thanks WG 11 for its document CAB/1309A/R, approves the draft Harmonized Basic Rules (HBR) of the IEC CA Systems as given in Annex 2 with the deletion of clause 7.9 and the modification to clauses 8.11 and 15 given below, and requests that they be circulated to all four IEC CA Systems, IECEE, IECEx, IECQ and IECRE, for their considerations including that on the elements which the CA Systems might desire to include in the HBR as their own Supplements. The CA Systems are requested to report back to CAB in time for discussion and decision at the GM 2015 CAB meeting.

8.11 The Executive Group of the IEC CA System provides an advisory function and is are empowered to make operational decisions between MC meetings, as delegated to them by the MC or CAB. They shall, in addition, carry out any other task(s) assigned to them by the MC or CAB. With the Chairman's agreement, members of the Executive may attend all meetings associated with the IEC CA System.

15 Appeals

Appeals concerning all IEC CA Systems that can't be resolved at the CA Systems level are handled by shall be escalated to the Board of Appeal of the CAB. Annex B sets out procedures of the Board of Appeal at the CAB level.

WG 11 action per this request – Done see 4 d) of the HBR

WG 10 Recommendation 4: WG 10 recommends that WG 11 develop a Guidance document for the use of Marks, Logos and CA System documents that would be relevant for the IEC CA Systems.

The potential loss of recognition as a leader in global CA services was updated as well. It was agreed by the WG that IEC CAB should develop a method to identify opportunities and the IEC should develop a mechanism for monitoring CA needs. The IEC CO and the IEC CA Systems should inform the CAB of potential opportunities and threats. There should also be consideration for a bundling of services offered by the different IEC CA Systems. It was proposed to develop a new Policy statement related to the IEC having a lead role in collaborative CA efforts. A query was made as to the meaning of the term "lead role", to which the term "proactive" was proposed as an equivalent term. The meaning being that IEC should be proactive in proposing global CA solutions to other standards organizations and encourage them to join in collaborative work when there is a market demand. The CAB thanks the IEC CA Systems for respecting CAB Decision 36/10 to return their feedback on the draft Harmonized Basic Rules (HBR) to CAB by this meeting. The CAB noting the feedback in documents CAB/1388/R, item 5.4, CAB/1429/INF, CAB/1455/INF,

CAB/1462/INF and REMC/050/DFA, tasks WG 11 with reviewing these documents and submitting a final recommendation to CAB.

Decision 38/12 — WG 11 CA Systems issues

The CAB thanked the WG 11 Convener for his verbal report of the meeting held in Frankfurt in the week prior to this CAB meeting, and encouraged this group to move forward quickly to complete both the tasks assigned to it as indicated in the document CAB/1413A/R, and the new task given to it in CAB Decision 38/8 concerning review and recommendations of the feedback on the Harmonized Basic Rules.

Action: WG 11 approved the timeline, noted the affirmative comments from CAB members, and suggested that the Systems Secretaries send Document CAB/1476/DC to their respective Systems membership noting the specific target dates that the Systems are required to meet. This will allow the Systems to initiate work in the development of their Systems Supplements as quickly as possible.

Action: The CAB Secretary circulate the Draft HBR along with the Compilation of Comments (for information) to the CAB for vote by correspondence following WG 11 final approval.

Action:The CAB Secretary is to query the CAB Chair as to permission to circulate the Draft HBR and Compilation of Comments to the Systems Secretaries at the same time as the HBR is circulated to CAB for Approval (an INF type document for the Systems circulation of the Draft HBR).

4.1.2. Continued Editing of HBR

WG 11 members reviewed the action items from the Tokyo meeting (per minutes) and addressed all concerns raised. The final version of the document is the version 3 document that was placed on the collaboration tools

WG 11 members also reviewed the action items (legal provisions and election rules) assigned to the CAB Secretary from the Tokyo meeting (per minutes) and addressed all concerns raised

Legal provisions and review of Clause 10 of the HBR:

Firstly, in reply to the request in the WG 11 Frankfurt meeting report, section 3.1.1, that the CO review Section 10 Legal of the HBR for completeness and accuracy, this has been done. After receiving legal advice and having conducted a thorough analysis, the CO considers the proposed legal clauses to be appropriate.

The UK still has some concerns as to the risk it may incur due to the current text in Section 10. It is understood, however, that the UK NC will be meeting with the GS & CEO in the near future.

• Election rules per DH document – Candidate voting procedure

DH provided a document that had been researched from various voting rules outside the IEC addressing the election process for more than two candidates, since there was no IEC standardized process.

KM provided an explanation as to the process followed in IECRE, as there were a number of recent elections with more than two candidates for the position. The main issue being that the Management Committee decided as to the process to follow.

Since this issue is not of an imminent need, the WG decided to hold this item for future revisions consideration and development.

The HBR was revised in Section 12 (see also comment 53 in the compilation of comments file) to indicate secrecy of ballots and confidentiality of results for Officer or other candidate elections.

Additional suggestions for consideration from David Hanlon – DH Suggestions

WG 11 Members reviewed Council Board Decision 2015/13 (see CAB/1470/INF) and took the following actions:

 <u>Stakeholder participation in the Systems</u> – WG 11 agreed that the Systems will compile a report for the June 2016 CAB Meeting on its activities to enhance industry involvement.

Action: Systems Secretaries to provide in their Systems report to the June 2016 CAB meeting on its activities to enhance industry involvement for CAB report to the CB in June 2016.

 <u>Stakeholder participation at the MB level</u> – WG11 added a new HBR requirement in Clause 5.1, 3rd paragraph requiring documentation as a part of the initial application process that describes the management organization, hierarchy, including subgroups, and an indication as to how the national interests can participate in the Member Body.

In addition, A new paragraph was added a the last paragraph to Clause 5.1 to address representation of all national interests at the Member Body level and to require that the Member Body report annually to the Management Committee on its efforts to support full representation of national interests within their Member Body. Action: Systems Secretaries to review their application documentation and determine if changes are needed to support the revision suggestion.

Action: Systems Secretaries will need to establish a process for collecting the data on representation of national interests at the Member Body level.

- Formation and operation of an executive committee WG 11 made a changes in the HBR (Clauses 8.2 and 8.11) in accordance with CB Decision 2015/013 request.
- Additional suggestions for consideration from IECEx and IECQ (Chris Agius)

WG 11 reviewed the suggested revisions related to minor changes in the Introduction and the Governing Documents section of the HBR and agreed to some minor revisions. The change to Section 4. Governing Documents related to the format to be used for the Supplements in Clause 4 g).

- ➤ Recommendation: There will be a single HBR document (IEC CA 01) and each System will have their own document (IECEE 01-S, IECEx 01-S, etc.) which contains ONLY the Supplementary requirements. The formatting of the Clause Number will use numbering convention used by TC61 (e.g. IEC 60335-2-65).
- Recommendation: References to Committees falling under the MC should be in the Supplement, as to name, function etc, but Operational issues (Structure, eg) for the Committee should be covered in 02 Rules of Procedure documents.

4.1.3. Voting/Non-voting - 2015/CAB/37/X6

From Item 10.1 of CAB/1401A/RM. The new Convener suggested that WG 11 should propose rules for the voting obligations of Member Bodies with some form of down-grading for non-response (along the lines of the Directives clauses 1.7.2 to 1.7.4) and that these should be included in the HBR. See item 63 in the CC

The WG drafted text using the terms "Voting" and "Non-Voting" to distinguish between the two levels of membership of Member Bodies. The only issue addressed is voting rights. There are no differences in the ability to attend meetings, comment on documents, make proposals, WG membership, dues, etc, between the level of Voting Member Body and Non-Voting Member Body.

The Recommendation, below, will be included in the Convener's Report to the 2016 June CAB meeting. The intent is that the proposed draft requirements be sent for consideration/comment from the Systems, and that, if/once approved by CAB, the revisions to the HBR be in a 2nd Edition so as to not delay the publication and implementation of the 1st Edition of the HBR.
