8.1 ISO/IEC 17050-1,-2 Decision 15/13 — ISO/IEC 17050-1 and ISO/IEC 17050-2 The CAB has considered the report of the IEC Coordinator in ISO/CASCO WG 24, and recommends to IEC National Committees to cast positive votes on ISO/IEC 17050-1 and -2 when they are issued for FDIS vote in June 2004.	Communication to NCs of the CAB's recommendation (Decision 15/13) for positive votes on these documents was missed. Procedures have been put in place to ensure that future CAB recommendations are communicated to NCs in conjunction with the publication of the relevant CABPUB/ document on the IEC server. NOTE — For both, of the 22 IEC National Committee votes, 21 were positive.
8.1.4 Handling of CASCO documents Decision 15/15 — Handling of ISO/CASCO documents in IEC The CAB approves the procedure for the handling of CASCO documents within IEC as outlined in CAB/457/DV and requests the CAB Secretary to implement the procedure as soon as practicable.	Decision 15/15 has been implemented with CABPUB/ documents being made available to NCs through the IEC Server.
8.3.1 Cooperation with ILAC Decision 15/17 — CAB-ILAC Technical Panel The CAB notes the report on the meeting of the CAB-ILAC Technical Panel held in April 2004 and welcomes the continuing strong cooperation outlined in the report. The CAB encourages each of the Schemes to participate in the joint activities with ILAC and its members, to maximize the benefits accruing through such cooperation.	Following the June CAB meeting and the Decision 15/17 (encouraging the Schemes to continue cooperation with ILAC), ILAC provided a draft of a proposed MoU between ILAC and IEC. This was considered by the members of the Joint Policy Panel (including the opportunity for comment from the Schemes' members) and subsequently by CAB (in principle) by correspondence. ILAC has been provided with a text approved "in principle" by the CAB for consideration at the ILAC General Assembly and final approval of the text of the MoU by the CAB will be considered under Agenda Item 9.3.4.
8.4 Cooperation with IAF Decision 15/19 — Cooperation with IAF The CAB notes the comments from the Schemes on the potential benefit of cooperation with IAF, requests the Chairman to initiate discussions with the IAF Officers on possible areas for cooperation, and report to the CAB at its next meeting.	As requested in Decision 15/19 the Chairman has held discussions with IAF officers on possible areas for future cooperation between IAF and IEC and his report will be considered under Agenda Item 9.4.
