- Procedures for issuing IECEx Mark Licenses, OD 022
 - □ Per minutes (ExMarkCo/33A/R) item 3.2, OD 022 is proposed to be amended to document the current ExCB Application Process
 - □ Reviewed and documented the current process and aligned OD 022 with IECEx 04A
- In process of revising any proposed changes to OD 022 should be sent to the Secretariat.
- A proposed new edition will be circulated for ExMC approval by correspondence

- 10.2 Notification of misuse of the IECEx Conformity Mark (and IECEx Logo)
 - □ ExMarkCo and Executive Committee are overseeing any misuse.
 - ☐ At this stage there are no current *significant* matters requiring either ExMC or CAB involvement. Items to note that have been reported:
 - IECEX Equipment Corporation (IEC)
 - IECEx fake certificate demonstrates that online system is working.
 Reported to CAB in June.
 - Report to ExMC and (through ExMC) to CAB that a couple of matters have been raised and dealt with by IECEx.
 - Members are asked to raise matters relating to misuse of the IECEx Conformity mark

- 10.3 Other Matters associated with the Mark
 - □ <u>ExMC/687/CD</u> –UK National Committee letter relating to the Surveillance of the use of the IECEx Mark
 - Proposal for the creation of an Addendum to the normal QAR form to be used by all bodies involved that reviews/tracks the following:
 - □ Details of products covered by License (including IECEx CoC #s)
 - □ Details on how each product is to be marked with the Mark; including documentation, packaging and promotional material as well as usage in catalogues and on websites
 - ☐ Manufacturer's quality management system details how they protect the use of the IECEx Mark
 - Request that ExMC delegate the task of creating such an Addendum to a Task Group comprising Members of WG5 and Ex Mark Co.
