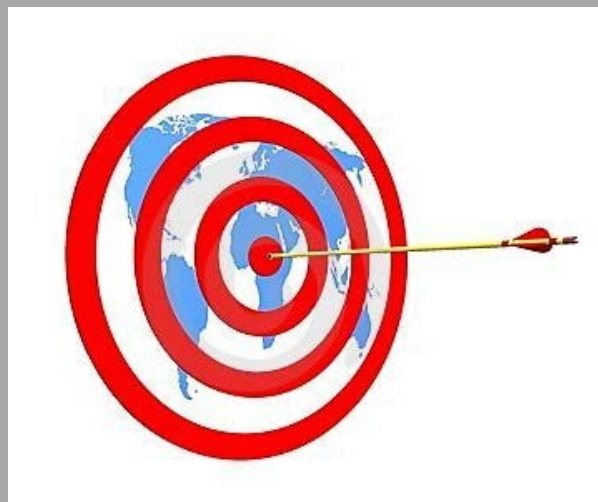

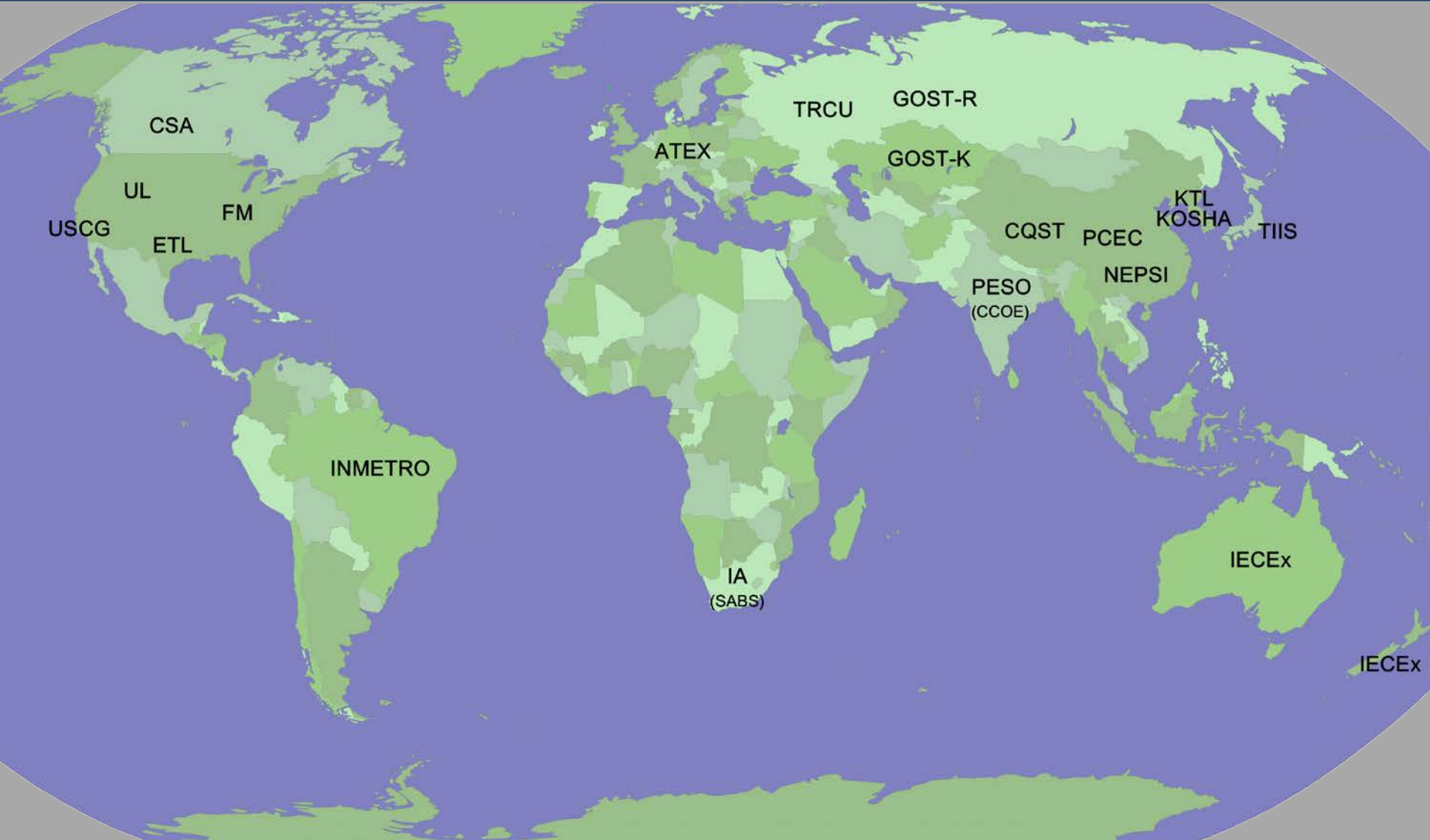
Today there are still too many several certification requirements throughout the world...

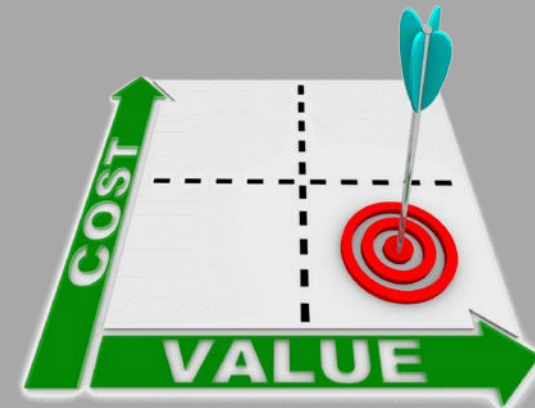

The objective of the IECEx System

is to facilitate international trade in equipment and services for use in explosive atmospheres

- Certified Equipment Scheme (IECEX 02)
- Certified Service Facilities Scheme (IECEX 03)
- Conformity Mark Licensing System (IECEX 04)
- Certification of Personnel Competencies Scheme (IECEX 05)

How to reach the objective of the IECEx System?



To reach the objective there's a high demand for **confidence**:

1. By the manufacturer – in the product assessment process
2. By the end user – in equipment, services and personnel covered by IECEx certification

How to use IECEx in gaining the international market?

Depending on acceptance:

Acceptance of IECEx Certificate of Conformity (CoC)

- + CoC legally accepted in Australia and New Zealand
- CoC not always (legally) accepted in other countries

Acceptance of IECEx Test Reports (ExTR)

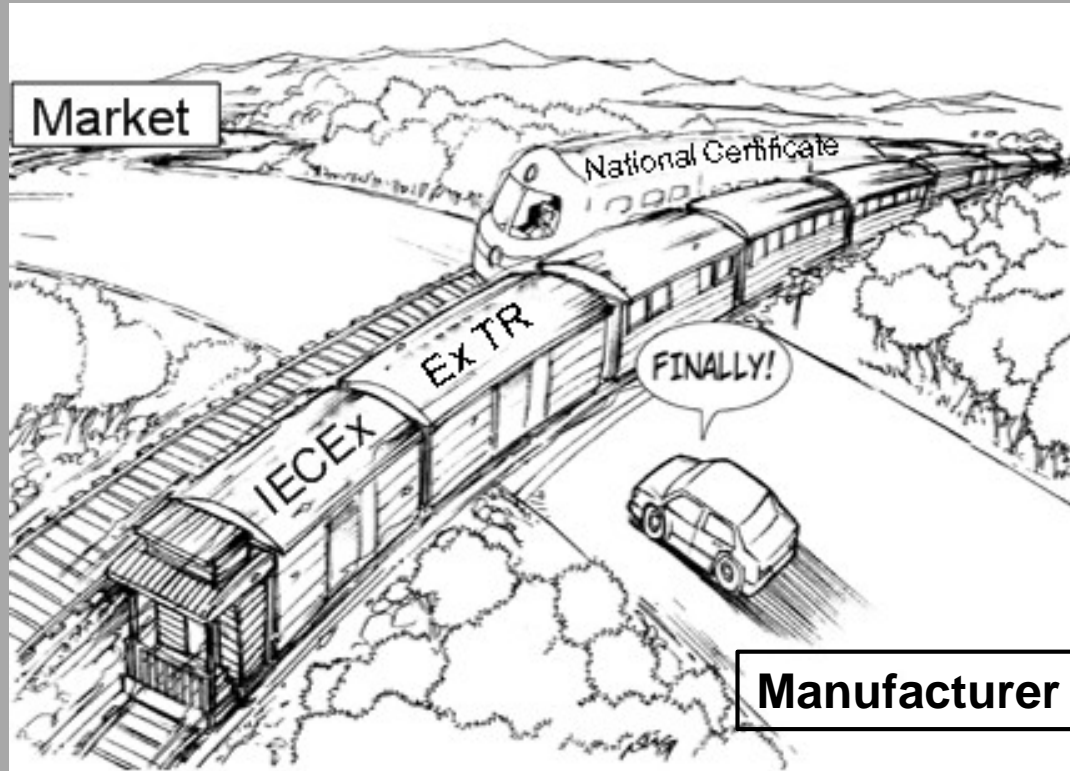
- + ExTR accepted in more than 30 IECEx member states (today 33 countries are member)
- + ExTR accepted as basis for National Certification

Acceptance of IECEx Quality Assessment Reports (QAR)

- + QAR accepted within the IECEx System by any other ExCB
- QAR not always accepted for National Certification

Taking the "fast track"!

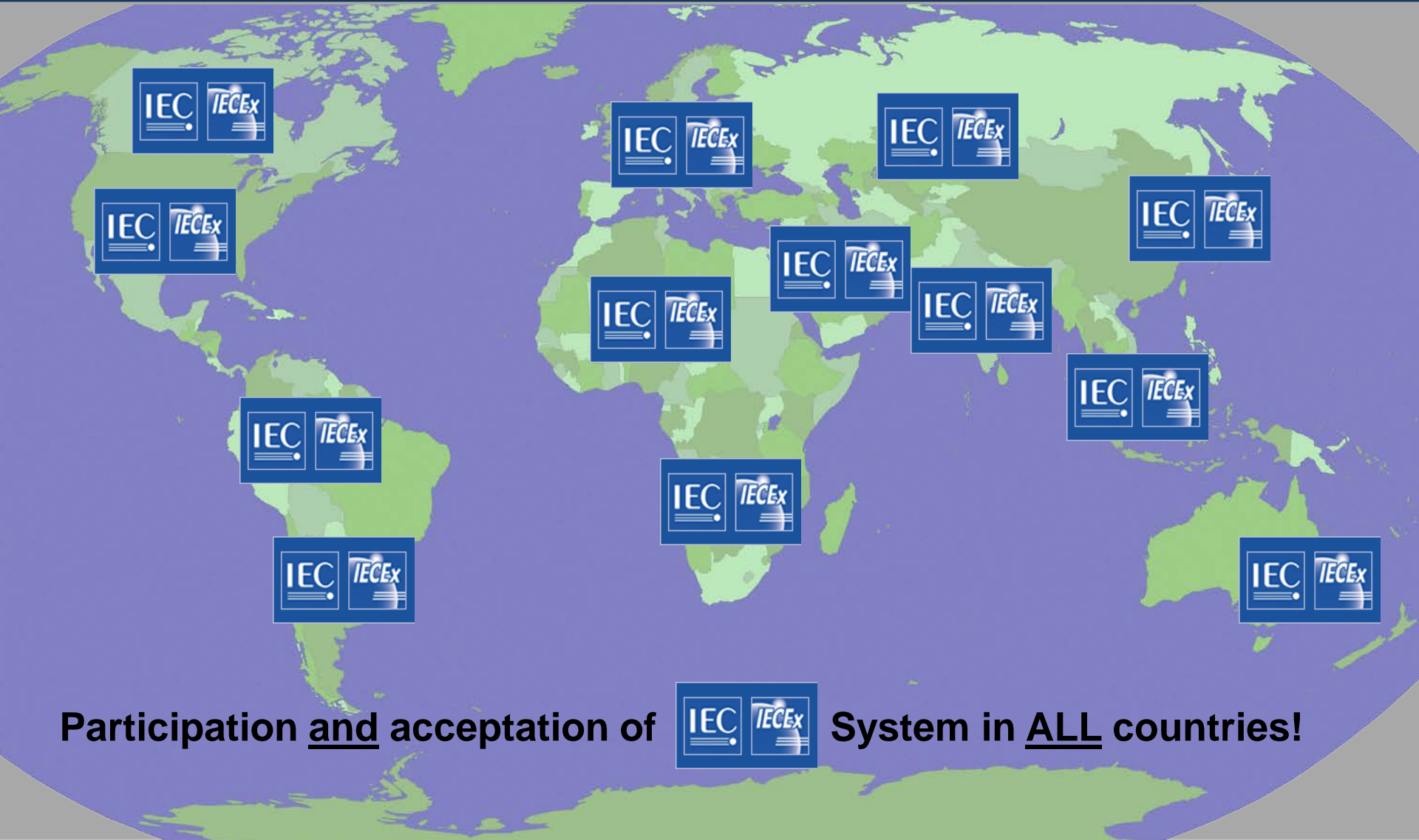
Reducing the time to market
