INTRODUCTION

This document sets out the report of the 7 May 2019 meeting of ExMC WG 1 held in Singapore as part of the 2019 IECEx series of Operational Meetings. The report includes the following 5 recommendations which will be presented for ExMC consideration during the September 2019 Dubai Meeting.

RECOMMENDATION 1: That WG1 agreed that: "Understanding of the application of Clause 6.6.4 Laser, Luminaires and other non-divergent continuous wave optical sources and the scope of IEC 60079-28 sufficiently to know if application of IEC 60079-28 is applicable" by adding an additional bullet point in the TCD to address the awareness of IEC 60079-28 and how the Assessors use the TCD for IEC 60079-0

<u>RECOMMENDATION 2 (from 2018 ExMC WG1 meeting)</u>: That ExMC support that AdHoc WG review clause 8.1.3 of IECEx 02 regarding content of the Certificate and revise so content captures all Manufacture locations as listed on the QAR.

<u>RECOMMENDATION 3:</u> That ExMC approve amendment to IECEx 02 Rules to reflect changes to clauses 8.1.3 and 8.3.3 that only require manufacturing countries be shown on the certificates and that all sites audited, Manufacturing sites and production sites to be listed on the QAR summary. (refer to revision of 02 clauses.)

RECOMMENDATION 4: Accept the minor editorial changes to OD 009 Ed 4.2, Section 4, as presented

IEC Conformity Assessment Systems Harmonised Basic Rules Members to receive a report from the IECEx Secretary regarding the status of <i>IEC Harmonised Basic Rules</i> and note the publication of: <i>IEC CA 01 Edition 2.3 – IEC Harmonised Basic Rules</i> <i>IECEx 01-S, Edition 2.0 – IECEx Supplement to IEC CA 01 {Pending CAB Approval}</i> Chris explained that the Basic Rules have been harmonised across IEC CA Systems via IEC CA 01 and that the Supplement IECEx 01-S has been created so it addresses specific requirements that are specific to IECEx. ExTAG recommends that ExMC WG1 considers the document ExTAG/500/CD relative to CoCs for Ex Equipment against performance standards for further guidance to ExTAG on this matter, noting the ExTAG decision to refer this matter to ExMC and possibly ExMC WG1 for consideration.	
The meeting recapped over the draft ExTAG Decision Sheet and the principle of whether or performance standards should be automatically applied, noting the current statement on IECEx certificates indicating that only the Standards listed on the certificate are covered. The meeting took a discussion whether or not this current statement is adequate, noting that if a Standard is not listed on page 2 of the Certificate then it is not covered.	
The meeting further noted that those using the IEC Standards and IECEx certificates should have a working knowledge to cover their respective roles and the knowledge on what the equipment is certified for. TC31 Chair confirmed that Standards do not automatically include a reference to performance standards as part of the Standards.	
TC-31 Chair explained history of -28. A draft interpretation sheet was published.	
Outcome: The meeting did not support the draft DS but would support the Draft DS with a reduced answer noting this WG Recommendation 1 relating to the updating of the TCD for IEC 60079-0 as proposed by ExMC WG2





Extract from original request as raised in Weimar:- Dear Mr. Agius: The USNC/IECEx request that ExMC WG1, Technical Revision of IECEx scheme rules, revise the IECEx Scheme Rules 02 to address acquisitions and mergers. IECEx 02, Clause 11.1.2, Application, is limited to addressing new applicant ExCBs to the IECEx Scheme. No consideration has been given to a situation of a takeover of an existing ExCB's operations by either an existing ExCB or a new legal entity. With the closure of ExMC/1225/DV, (i.e., the IECEx Report for the acceptance of the transfer of ExCB and ExTL activities from TUV Rheinland Australia to Ex Testing and Certification Pty Ltd), WG1 has an example for developing a proposal to revise IECEx 02 to address submission of an application from either an existing ExCB or a new certification body seeking to become an Ex Certification Body through the acquisition or merger with an existing Ex Certification Body.

The meeting agreed with Mike S. and in noting the current ExTAG Decision sheet on this issue agreed for him to prepare a draft revised DS to DS 2012/010 to allow use of the internet for instructions and that WG1 support this approach and for this to proceed via the normal process of OD 035.	
Karel Neleman raised the issue of replacing components of Certified equipment that is in the field but not during the manufacturing? The meeting discussed this noting the responsibility of the end user versus the responsibility of the manufacturer under certification. Marty Cole reinforced that the CoC is only valid when it ships out the door, once installed it is the responsibility of the owner. The meeting took a brief discussion and concluded to maintain a watching brief on this issue.	
Karel then raised the issue of thermal overload protection devices such as covered by IEC TS 60079-42 with the Secretary advising that the Executive are considering this new standard for inclusion in IECEx with Mr Massey suggesting that the ExMC may need to be involved in this decision.	
Karel Neleman – also raised the concern of CoCs remaining on line and showing as having been Suspended for up to some 6 years. Mike Roy of the Secretariat noted this and advised the meeting that as part of his "IECEx Compliance Manager" responsibilities he is chasing ExCBs.	
ACTION: Secretariat Compliance will be addressing CoCs suspended for greater than a year requiring Cancellation as per rules with ExCBs.
